To sign up, enclose the following in an envelope marked **EasyPay**:

1. This completed and signed application.
2. For Checking Accounts: a **voided check**, account number & the ABA/bank routing number; For Savings Accounts: account number & the ABA/bank routing number.
3. Mail the application and voided check to: **EasyPay, P.O. Box 9017, Temecula, CA 92589**
4. Please do not include your payment in the envelope with the EasyPay application. This may cause delays in posting your payment.

I further understand that if two payments are returned because of insufficient funds within a twelve-month period my participation in the EasyPay program may be automatically cancelled. Additionally, payments returned due to insufficient funds are subject to return check fees and late payment penalties.

By authorizing RCWD to deduct funds from my account, I acknowledge that payment of my water bill remains my sole responsibility. I agree and understand that RCWD cannot be responsible for any failures of my financial institution to transfer funds, failure of mine to maintain sufficient funds in the paying account, or for any failures of transfer due to problems arising from problems in the electronic funds transfer system.

It is RCWD's policy to protect the integrity of its customer's financial information and records at all times. By signing below and authorizing the deduction of funds from my account, however, I agree and understand that RCWD has no control over the electronic funds transfer process and, therefore, cannot guarantee the security of my financial information.
