The site address is generally 43250 Elm Street, near Date Street and Hayes Avenue. The soils disposal site is also in a portion of the Rancho Temecula Land Grant lying within projected Sections 21 and 28, Township 7 South, Range 3 West, San Bernardino Base and Meridian as shown on the United States Geological Survey 7.5 minute Murrieta, California quadrangle. <p>Project Description: Construction of an additional recycled water storage pond (capacity of approximately 335 acre-feet with a surface area of approximately 25 acres and an average depth of 12 feet), one 16-inch diameter inlet pipeline, one 24-inch diameter outlet pipeline, paving the existing access road along Elm Street, lining the existing Pond No. 4, constructing access ramps with turnarounds in Ponds No. 1, 2, and 3, and the storage of approximately 1.5 million cubic yards of excess soil. The purpose of the project is to store recycled water in order to meet peak summer demands for recycled water and to reduce potable water demands for customers within RCWD's service area.</p>
